With a deal on the EU's 2030 climate and energy policies foreseen in October 2014, the **APRAISE Final Conference "What Role for Targets in EU Climate and Energy Policy? - Lessons from the APRAISE project for Improved Environmental Policy Making"** was successfully implemented on the 24th of September 2014, in Brussels, Belgium.

The APRAISE Final Conference, drew on the results of the APRAISE project

assessing how past experience in environmental policy making can contribute to more informed decisions for the future, while it also highlighted that climate and energy policies are not formulated within an isolated policy context, but rather implemented in existing (market) systems. Finally, the APRAISE Final Conference based on the APRAISE case studies in the area of renewable energy and energy efficiency policies, therefore providing for a better understanding of the mechanisms of environmental policy.
